- Loitering and/or trespassing will not be permitted.
- Bicycles will not be permitted in the park.
- Tobacco & Alcohol are not permitted in the park.
- Weapons are not permitted in the park.
- Profanity will not be tolerated.
- Helmets are required to skate. Other safety equipment is highly recommended.
- Management reserves the right to schedule organized activities.
- Meijer Park shall not be held liable for loss, theft or damage to the personal property of any member or guest.
- All skaters must provide their own equipment.
- Food/Beverages are allowed only in designated areas.
- Skateboards/In-line skates may be used in designated areas only.
- Equipment and facilities will be used in accordance to posted regulations.
- Behavior dangerous to others is not allowed.
- Management reserves the right to inspect any items brought into the park.
- The facility is used by both experienced and inexperienced skateboarders/inline skaters. Serious injury may result from being hit by a skateboard, falling or colliding. The owner does not assume responsibility for injuries.
- Skate at your own risk.
- Violation of these rules and regulations is subject to expulsion from the park indefinitely.

In consideration of being allowed to participate in any way with the Southeastern Livingston County Recreation Authority, Meijer Skatepark, related events and activities, the undersigned acknowledges, appreciates and agrees that:

- 1) The risk of injury from the activities involved in this program is significant, including the potential for permanent paralysis and death, and while particular rules, equipment, and personal discipline may reduce this risk, the risk of serious injury does exist: and,
- 2) I KNOWINGLY AND FREELY ASSUME ALL SUCH RISKS, both known and unknown, EVEN IF ARISING FROM THE NEGLIGENCE OF THE RELEASEES or others, and assume full responsibility for my participation; and,
- 3) I willingly agree to comply with the stated and customary terms and conditions for my participation. If, however, I observe any unusual significant hazard during my presence or participation, I will remove myself from participation and bring such to the attention of the nearest official immediately; and,
- 4) I, for myself on behalf of my heirs, assigns, personal representatives and next of kin, HERBEY RELEASE AND HOLD HARMLESS SOUTH EASTERN LIVINGSTON COUNTY RECREATION AUTHORITY their officers, officials, agents, and/or employees, other participants, sponsoring agencies, sponsors, advertisers, and if applicable, owners and lessors of premises used to conduct the event ("RELEASES"), WITH RESPECT TO ANY AND ALL INJURY, DISABILITY, DEATH, or loss or damage to person or property, WHETHER ARISING FROM THE NEGLIGENCE OF THE RELEASEES OR OTHERWISE, to the fullest extent permitted by law.
- 5) My personal insurance will cover all medical costs for any injury incurred by myself/my child
